

Hunger on the Ballot: Systemic Racism



The most significant root cause of hunger is poverty. And poverty, itself, is driven by a host of systems and structures, with racism and other forms of discrimination at the top. This means racial justice work is anti-hunger work; anti-hunger work is racial justice work. We can't successfully pursue one without the other.

Over more than three decades, our work to address food insecurity — and our own lived experiences — confirm the undeniable connection between hunger, racism and other systemic inequities. Many of these systems go back generations. Some exclusions go all the way back to our state's founding. Some of the worst remain active and enforceable to this very day. And our fall ballots present an opportunity to fix it.

People are not property — and slavery and other types of involuntary servitude should have no place in our laws in 2022, period. Measure 112 will remove all language from the Oregon constitution that allows slavery as a form of punishment.

To move toward an equitable future where no one in our communities knows hunger, we need to correct past wrongs — especially those that remain today. Vote YES on Measure 112 to remove slavery and involuntary servitude from the state constitution.

New Covid Policy for Mountain Home UMC

Dear members and friends of Mt. Home United Methodist Church, moving into the fall of 2022 and with permission from the Cascadia District we've revised our COVID policies to the following:

Pastor Aric will continue checking our local statistics weekly on <u>covidactnow.org</u>, with an emphasis on hospitalization numbers.

- I. While we are in the low (green) category in Washington County all activities are permitted. This means in-person worship, indoors if desired or if the weather requires, masks-optional, singing permitted, and fellowship and other activities allowed.
- While we are in the medium (orange) category in Washington County masks will become required
 indoors and we will take special precautions with certain activities such as food, and fellowship etc..
 Singing is still permitted at this level.
- 3. While we are in the red (high) category in Washington County we will worship outdoors if possible, or on zoom if not possible due to weather. Other indoor activities will be suspended.
- We will continue tracking attendance at church events for the purpose of contact-tracing if anyone gets covid.
- Masks will always be optional outdoors.
- Members are encouraged to continue observing best-practices for everyone's health and safety.
- I. Get your vaccines and boosters!
- 2. Wear masks in crowded public situations
- 3. Wash your hands regularly
- 4. Maintain social distancing in public
- 5. Use home-tests if you experience symptoms or have been exposed recently to covid.
- 6. Don't come to worship if you have recently been exposed to covid, have symptoms, or have tested positive.
- 7. If you test positive for covid after attending an event at the church inform us so that we can tell others who may have been exposed.
